## **Application Instructions**

**This is a two-step process which will require applicants to send documents to two different offices. ### **Step 1: Complete the Application for Probate Referee**

- Include your email. Write your email address on the upper, right corner of the application
- Include a check or money order in the amount of \$75.00 made payable to the Office of the State Controller. This fee is not refundable.
- Applications must be received by CPS HR Consulting no later than March 21st, 2025.
